Foreshore Report

Foreshore O - Mr. Al Phillips

- 1. We plan on assigning dinghy spots starting on 01 July or sooner after we know who has been approved for a berthage spot in Sept for the winter. Priority to members on the dock and then based on volunteer time and then those with nothing.
- 2. Dinghy docks have been numbered
- 3. Refunded one berthage fee from this past season, no acceptable room at the dock.
- 4. Member living on boat on a mooring ball. Using the club house daily for washroom and parking. Do we want to promote a culture of liveaboards joining the club so they have a place to clean-up and park? (this is a new member).
- 5. Shed on dock has been painted (Thanks Tom Letsinger!)
- 6. Wind socks up on docks to aid in docking
- 7. Red ball by the club mooring removed
- 8. Dive club boat cleaning and mooring balls complete (Thanks to OPI Matt Davidson).
- 9. Reminder that Berthage Applications must be in by 31 May 2025. Action: Allison to add to newsletter.

Keelboat Division Report

Maj Marc Archambault - Keelboat Capt

Please include <u>asst-keelboat@19wcyc.com</u> in future exec comms. John Deckers has agreed to take on the challenge of tracking the maintenance for the keelboats and so far has done a stellar job of getting a few projects back on track!

1. Training

18 Students. 5 crews have started, one crew still has to do lesson # 1. Training stalled due to ATW being broken (see boat reports below). We may have to cancel/refund a few training slots due to limited time from now until last test date (est 15 June), due to limited availability of our tester. Not ideal, but simple math when considering 18 students (plus 3 from last year) and only 1 boat anticipated for the spring. To be discussed this week with the training team once we have ETS for Hawk / ATW. MTF.

It has been noted that instructors are ignoring the no-go conditions listed in the vessel checklist, in one case likely causing serious damage to ATW. Instructor re-training to occur before resumption of student training.

2. ATW

Tiller/Rudder boats was overstressed and broke. Part unavailable (no longer manufactured) from OEM. Local marine welder will fab, at a cost of aprox \$1000. Welder advised that breakage pattern is representative of overstress (bent, twisted, then sheared). Rudder post appears lower than it was prior to damage. Vessel will have to be put on the grid in Comox to inspect gudgeon/pintle and play prior to returning to service.

Vessel was taken out for training when marine forecast and marine wx reports called for 20-30 kts, when checklist clearly states do not leave the dock when winds >= 18 kts. Instructors also going out when "engine is grinding gears" and when mainsail doesn't go all the way up. General lack of care of club assets is not setting the right example for students/prospective renters. Re-training session to be completed with instructors prior to resumption of student training to clarify use of checklists.

3. Hawk

Blanchard Rigging is completing standing rigging and running rigging replacements. ETS expected in next the week, then test sail and checklist / log book development, followed by instructor on-water famil. Could be ready for training by 17 May if all goes well in next few days.

PG

Awaiting service call for minor fuel leak and sea trial due to excessive propeller noise under way and under sail. These issues also holding back renter check-outs.

5. Work party

Lots of work completed last Sunday, with approx. 15 volunteers working on 3 club boats.

6. Communication

Suggest we discuss communication prioritization strategy to club members. Notifications for advanced courses are being sent out 2-3 weeks after email request generated, thus members only receiving the course notification 2-3 days prior to the classroom session.... Receiving some angry phone calls as interested member can't attend with 2 days notice.
