- As a condition of having and using mooring facilities at GRN Petawawa, Jubilee Lodge Marina, I \_\_\_\_\_ (hereinafter called the releaser, which includes my heirs, executors, administrators, and assigns) hereby remise, release, and forever discharge His Majesty the King in the Right of Canada. Jubilee Lodge Marina and his Majesty and their officers, servants and employees (hereinafter called the releases with includes Him and their heirs, executors, administrators, successors and assigns) from all manner of actions, and claims or demands which against the release. I had, now have or may hereafter have any matter arising out of the mooring of a boat at Garrison Petawawa. And without limiting the generality of the foregoing, by reasons of any injuries I receive of damage to any boat I own or under my control while using the Jubilee Lodge Marina, Docks, boats installations, buildings or grounds.
- I, \_\_\_\_\_ also hereby acknowledge and agree as a condition of using the mooring facilities at GRN Petawawa limiting the provisions of paragraph one that I am solely responsible for the security and insurance of my own boat or any boat under my control and will make no claims against the release for any loss, theft of the boat, and any theft, loss or missing articles either from the boat or any property under my control which I bring into the buildings, docks, mooring, installations, or grounds of GRN Petawawa, Jubilee Lodge and Marina.
- In addition as a condition of using the mooring facilities at GRN Petawawa / Jubilee Lodge and Marina. I do hereby agree and covenant with the released. That I will at all times indemnify and save harmless the said releases from all claims, demands, suits or actions or claims for contribution or indemnity whether under any negligence act or otherwise which may be made by me, my spouse, children, dependants, or guests on my or their behalf which may arise. The mooring of my boat or any boat under my control, at GRN Petawawa / Jubilee Lodge and Marina, facilities including the costs of defending such suits, actions or claims.
- In as a condition of membership and in order to use mooring facilities I must provide all the information required on this application prior to using the mooring facilities.
- If you decide to sell your boat before the season ends, slippage fees will not be refunded. Any sub-letting or seasonal leasing of slips must be conformed and approved by Jubilee Lodge office staff.
- Storage Contract must be completed before storing your boat for a season. Storage rates are Regular \$150; Ordinary \$160; Associate \$175 plus HST payable to Jubilee Lodge directly. Winter storage is from 31 October 2024 to 31 May 2025. Winter storage fees must be paid as of 31 October 2024. Summer storage rates from 1 June 2024 to 1 November 2024. Penalty for non-payment of \$50/week will be charged to your account.
- It is the boat owner's responsibility for launching and hauling in/out of their boats. Jubilee Lodge Marina nor the PYC do not provide these services.
