Definitions

Family - A family consists of the applicant, their spouse and children.

Children - Son(s) and/or daughter(s) of the applicant and/or spouse that reside at the applicant's permanent address and 18 years old or younger.

- Son(s) and/or daughter(s) who are 19-25 years of age and attending school full time.

- A physically and/or mentally challenged son/daughter residing at the applicant's permanent address.

Spouse - Legally married to or living common law with applicant.

Student Rate: Full Time Students Only, Valid student ID required.

Senior: Over the age of 55 years, for a family membership at the senior rate, both adults must be over 55 yrs.

PSP PLAN DISCOUNTS WILL NOT BE ISSUED FOR MEMBERSHIPS LESS THAN 6 MONTHS IN LENGTH. THIS INCLUDES SWIMMING LESSONS AND ALL COMMUNITY RECREATION PROGRAMS.

Community Recreation One Club Membership

FAQs

What is a One Club Membership?

A One Club Membership is available to any Non PSP Plan members who are interested in joining a Garrison Recreational Club.

What is the difference between a One Club Membership and a PSP Plan Membership?

When a Non PSP Plan member joins a club, they pay the club fee PLUS the additional \$45 plus tax for the One Club Membership. A PSP Plan member would only pay the club fees. A One Club Membership is not eligible for the additional benefits that a PSP Plan membership includes such as: use of Dundonald Hall, Community Recreation program discounts, discounts at other PSP entities like the Jubilee Lodge & Marina and Black Bear Campground.

If more than one family member joins the same club, do I have to purchase more than one One Club Membership?

It extends to the entire family for the club it was purchased for. A Non PSP Plan family is required to purchase a single One Club Membership regardless of how many family members participate in that club.

What if we want to join more than one club?

A One Club Membership is valid for one club for one year only. If two members of the same Non PSP Plan family belong to different clubs, the family would be required to purchase two One Club Memberships. If a single Non PSP Plan member wants to join more than one club, they would pay the \$45 plus tax fee for each different club they belong to.

If I don't have a PSP Plan card, how do I get into a base facility to participate in my club?

The Recreation Complex will issue One Club ID Cards to anyone who purchases a One Club Membership. They will issue one card per family member and the card will be valid for one year.

Will my One Club membership get me discounts at Black Bear Campground or Jubilee Lodge?

The Jubilee Lodge & Marina and Black Bear Campground are not included in the One Club Membership Program. However, discounted rates are offered for full PSP Plan membership holders.

Can I buy a One Club Membership if I only want to use Dundonald Hall?

Civilian access to Dundonald Hall is available only through a PSP Plan card. Dundonald Hall is not included in the One Club Membership program. Daily passes are available for Non PSP Plan members.

Can I buy a One Club Membership for Swim Lessons or Summer Camp?

Any program offered by Community Recreation is not included in the One Club Membership program. All programs offer discounted prices for PSP Plan members. Non PSP Plan members can participate in any Community Recreation program, but they will pay a different price than a PSP Plan member.
