

**House Rules for Canadian Forces Morale and Welfare Services, CFB Halifax PSP Royal  
Canadian Air Force Centennial Air Canada Raffle Draw Lottery License #AGD-341257-24**

Last revised 10 June 2024

1. A maximum of 1000 tickets will be sold at a cost of \$20.00 per ticket.
2. Ticket purchaser must be 19 years of age or older.
3. There is no minimum number of tickets that must be sold.
4. Only tickets that have been paid for, and verified as paid for, shall be eligible for the draw. Payments can be made by cash, debit, or credit.
5. The winner's name will be published online.
6. The licensee is not responsible for lost or stolen tickets.
7. The draw will take place at the 12 Wing Shearwater Royal Canadian Air Force Centennial Meet and Greet, on Thursday, 17 October 2024 at the 12 Wing Combined Mess, 141 Warrior Avenue, Shearwater, NS B0J 3A0, at 1630hrs.
8. Tickets will be sold between 0800hrs on 17 June 2024 and 1600hrs on 10 October 2024
9. Tickets will be sold to any eligible member of the Canadian Armed Forces or Defence Team. Proof of Canadian Armed Forces or Defence Team status must be provided when verifying the winner.
10. Each ticket will have a unique serial number on both portions of a perforated ticket. The ticket purchaser's contact information will be filled in by the purchaser on the portion that remains with the seller. The purchaser is responsible for placing their ticket in the designated box provided at the selling location. The remaining half of the ticket must be kept secure by the purchaser, as it will be required for proof of purchase when claiming the prize.
11. All ticket stubs will be placed in a drum, with a member of the public not holding a ticket or an interest in the draw responsible for pulling the winning ticket.
12. The winner will receive Air Canada travel vouchers for one (1) round trip for two (2) persons in Economy Class for travel to Europe or North Africa. Travel must be completed by 31 October 2025. Tickets are valid for travel on Air Canada, Air Canada Express, and Air Canada Rouge scheduled flights only (not valid on Star Alliance partners or code-sharing carriers). Certain conditions and \*blackout periods apply and will be outlined to the winner upon receipt of the prize. The trip is valued at CAD \$6000.00.

13. There will be no cash value in lieu of or cash alternative option to the prize. The prize must be accepted as presented. There will be no exchanges, refunds, or returns. Prize may not be exchanged for cash value.
14. The winner will be responsible for any costs outside of the round-trip tickets as described above.
15. Value of the prize is the approximate retail value as of the date that any contracts may have been negotiated with suppliers and/or the date that the lottery application is received. Due to economic fluctuations, the market value of the prizes may rise or diminish over time. Neither the winner nor the licensee is entitled to the difference, if any, between the stated and actual market value at the time the prize is awarded. Neither the licensee nor the licensing authority is responsible for any change in value.
16. The winning stub drawn must be filled out completely with purchaser's contact information. If the contact information is not complete and/or legible as deemed by the licensee, it will be considered null and void, and another ticket will be drawn immediately.
17. If more than one name is written on the winning ticket stub, the prize will be awarded to only one of the individuals named on the winning ticket stub. The licensee is not responsible for any disputes among individuals regarding the winning ticket stub.
18. The ticket purchaser does not have to be present at the draw to be eligible as the winner.
19. When claiming the prize, the winner must present their portion of the winning ticket stub, proof of residence in Nova Scotia, and provide proof of Canadian Armed Forces or Defence Team Member status.
20. The ticket purchaser has ninety (90) days to claim the prize. If this timeline is not met, a subsequent winner will be drawn by the licensee.
21. The name on the first eligible ticket will be audibly announced at the time of the draw. If the winner does not immediately present themselves to the stage, a phone call will be made to the number on the ticket. If there is no initial response, a voicemail will be left (if possible).
22. Attempts to reach the winner will be made by phone at a minimum of once (1) weekly, until the ninety (90) day timeline has been reached. If the ticket purchaser has not claimed the prize by the ninety (90) day period, a new winning ticket will be drawn, and the previously drawn ticket will no longer be eligible. The ninety (90) day period will start over with the new winning ticket. Upon reaching the 31 October 2025 expiry of the vouchers the process of determining a winner will cease.
23. All proceeds from this raffle will be used for the 12 Wing Shearwater Legacy Aviation Park to be located at Autoport Avenue, across from the Shearwater Aviation Museum.
